Tax Information

Overview

Taxes are required to be charged on reservations made for owner stays at certain resorts. These taxes can have different names and may be assessed differently depending on how the reservation is charged. The taxability of stays and the rate at which the nightly stays are taxed vary by taxing authority (state and/or local) based on the location of the resort. Rates are not determined by WorldMark and are subject to change without notice. Any applicable taxes must be paid in full at the time a reservation is made.

Types of Taxes

Transient Occupancy Tax (TOT)

At certain resorts, a Transient Occupancy Tax is charged on a per night and room size basis on all reservations booked with credits.

Credit Conversion Tax (CCT) - NEW

When using credits at certain resorts, the credits used are converted to a dollar amount using a cents per credit formula. The dollar amount is then taxed a percentage amount similar to Lodging or GST Tax. The bonus time rate is currently used for conversion.

Lodging Tax (LT)

At certain resorts, a Lodging Tax is charged on a percentage basis of the total reservation cost on reservations booked with a cash payment option, such as bonus time, inventory special, or FAX time. In certain areas, Lodging Tax may also be assessed on cash housekeeping charges.

Goods and Services Tax (GST)

Similar to Lodging Tax, a Goods and Services Tax is a value-added tax charged on percentage basis of the total reservation charge at Canadian resorts and Club Wyndham South Pacific resorts. In certain areas, Goods and Services Tax is also assessed on cash housekeeping charges.

Sales Tax (ST) - NEW

Certain tax jurisdictions require a state or local sales tax to be paid on reservations booked with a cash payment option such as bonus time, inventory special, or FAX time. Sales tax may also be assessed on cash housekeeping charges.

Nightly Surcharge (NS)

At certain resorts, a flat rate per night tax is charged in addition to the Transient Occupancy Tax, or Lodging Tax. These rates are assessed by the local jurisdictions and is based on the number of nights of a reservation.

Other Miscellaneous Onsite Charges

Energy Surcharge

An Energy Surcharge is a daily fee assessed by a resort to cover additional power costs associated with certain locations. Unlike taxes, the Energy Surcharge is not collected at the time of booking but is secured by credit card during check-in at the resort, and is processed upon check-out.

Miscellaneous Government Taxes

The Virgin Islands Revenue Enhancement and Economic Recovery Act of 2017 requires timeshare owners, guests of owners, and exchange guests to pay a \$25 fee per unit per night for the duration of their stay. In accordance with this law, WorldMark collects this fee upon check-in at applicable resorts.

Onsite Charges at Non-WorldMark Resorts

Any assessed taxes on reservations at WorldMark resorts are usually collected at the time of booking, however our affiliate resorts may have assessed taxes that are collected at the time of check-in. Please be aware that when booking a Wyndham Club Pass resort you may be asked to pay any assessed taxes upon arrival. Please contact the resort's front desk for specific information.
